- Applicants must submit an official high school transcript along with this application. Applications will NOT be processed without official transcripts. (If you previously submitted transcripts for a PSEO Application, you do not need to re-submit.)
- Juniors or seniors must have a cumulative 2.5 GPA for all high school coursework completed.
- Freshmen or sophomores must have a cumulative 3.0 GPA for all high school coursework completed.
- Applicants under the age of 15 must first complete the Accuplacer assessment, and then must contact the Vice President of Student Affairs to schedule an interview, prior to submitting this application.
- Applicants that would like to register for a course that has a mathematics or English prerequisite requirement must complete the Accuplacer assessment to determine course placement.
